## 2. <u>Procedures of Tender</u>

2.1 The Vendor invites tenders for the purchase of the Property for Tender on the terms and conditions contained in this Tender Document.

- 2.2 The Vendor does not bind itself to accept the highest or any tender and reserves the right to accept or reject any tender at its sole discretion.
- 2.3 The Vendor reserves the right to, at any time before the Tender Closing Date, accept any tender submitted.
- 2.4 The Vendor reserves the right, at any time before acceptance of a tender, to withdraw all or any of the Property for Tender from sale or to sell or dispose of all or any of the Property for Tender or any part thereof to any person by any method (including without limitation private treaty, tender and auction).
- 2.5 The Vendor reserves the right to adjust the Tender Closing Date and time of the tender of any of the Property for Tender. Any adjustment of the Tender Closing Date and time will be posted at the Sales Office. The Vendor is not obliged to separately notify the Tenderers of such adjustment.

- 2.8 In case a black rainstorm warning signal or a typhoon signal no.8 or above is announced or is still in effect after 11:00 a.m. on the Tender Closing Date, the closing date and time of the tender will be extended to 11:00 a.m. to 12:00 noon on the next day and in respect of which no black rainstorm warning signal or typhoon signal no.8 or above is announced.
- 2.9 All cashier order(s) and/or cheque(s) forwarded by the Tenderer will be retained and uncashed until the Vendor has made its decision on the tenders submitted. If a tender is accepted, the cashier order(s) and/or cheque(s) submitted therewith will be treated as the preliminary deposit towards and applied in part payment of the Purchase Price. All other cashier orders and/or cheque(s) will be returned by personal delivery or by post to the unsuccessful Tenderers at the address stated in their tenders.
- 2.10 (a) The Tenderer must sign the Offer Form and other documents personally (if the Tenderer is a company, by its director) and shall be deemed to be acting as a principal.

- 2.11 (a) In consideration of the invitation of tender by the Vendor and of the promise by the Vendor

mentioned in sub-paragraph (b) below, every tender shall be irrevocable and shall constitute a formal offer capable of and remain open for acceptance by the Vendor during the Acceptance Period. After the tender has been submitted in accordance with the procedures set out in this Tender Document, no Tenderer shall be at liberty to withdraw his tender and the same shall be deemed to remain open for acceptance by the Vendor until the end of the Acceptance Period.

(b) In consideration of the provision and undertaking referred to in sub-paragraph (a) above, the Vendor promises to pay the Tenderer HK\$1.00 upon receipt of a written demand from him prior to the submission of his tender.

#### 3. Acceptance of Tender

- 3.1 If a tender is accepted, the successful Tenderer shall become the Purchaser of the Tendered Property.
- 3.2 The Purchaser will be notified of the acceptance of his tender by a letter (the "**Letter of Acceptance**") personally delivered to him at and/or posted to the Hong Kong correspondence address stated in his Offer Form on or before the end of the Acceptance Period. The Letter of Acceptance will be deemed to have been duly received on the second working day after the day of posting.
- 3.3 The Purchaser shall, within five (5) working days after the date of the Letter of Acceptance, sign the Agreement in the standard form prepared by the Vendor's solicitors without any alteration or amendment thereto. The standard form of the Agreement is available for inspection during the Tender Period at the Sales Office. For the avoidance of doubt, the Purchaser shall be deemed to have inspected the standard form of the Agreement and the Purchaser shall accept the same without amendments.
- 3.4 (a) In the event that the Purchaser intends to execute the Agreement by his/her attorney on his/her behalf, the relevant power of attorney is required to be approved by the Vendor.
  - (b) All loan applications made to the Vendor's designated financing company, loan documents and ancillary documents (collectively the "Loan Documents") shall be signed by the Purchaser personally. No attorney can be accepted for the purpose of signing the Loan Documents.

#### 4. <u>Miscellaneous</u>

- 4.1 Tenderers are advised to note that the Vendor will only answer questions of a general nature concerning the Property for Tender and will not provide legal or other advice in respect of this Tender Document or statutory provisions affecting the Property for Tender. - 4.2 Any statement, whether oral or written, made and any action taken by any officer or agent of the Vendor or the Vendor's agent in response to any enquiry made by a prospective or actual Tenderer shall be for guidance and reference purposes only. No such statement shall form or be deemed to form part of this Tender Document or the Agreement, and any such statement or action shall not and shall not be deemed to amplify, alter, negate, waive or otherwise vary any of the terms or conditions as are set out in this Tender Document or the Agreement.

#### PART 2: CONDITIONS OF SALE

- 1. In these Conditions of Sale, terms defined in the Tender Notice shall have the same meaning when used herein. The Tender Document and the Letter of Acceptance shall constitute a binding agreement between the Vendor and the Purchaser for the sale and purchase of the Property. The Vendor shall sell and the Purchaser shall purchase the Property at the purchase price and on the terms and conditions contained in this Preliminary Agreement.
- 2. In this Preliminary Agreement:-
  - (a) "saleable area" has the meaning given by section 8 of the Residential Properties (First-hand Sales) Ordinance;
  - (b) "working day" has the meaning given by section 2(1) of that Ordinance.
  - (c) the floor area of an item under clause (a) of each Property set out in "Measurements of the Tendered Property" of the Tender Document is calculated in accordance with section 8(3) of that Ordinance; and
  - (d) the area of an item under clause (b) of each Property set out in "Measurements of the Tendered Property" of the Tender Document is calculated in accordance with Part 2 of Schedule 2 to that Ordinance.
- 3. The preliminary deposit payable by the Purchaser shall be held by the Vendor's solicitors as stakeholders.

It is hereby agreed and declared that this Preliminary Agreement is personal to the Purchaser, and the Purchaser shall have no right to request the Vendor to enter into the Agreement with any other person and shall have no right to transfer the benefit of this Preliminary Agreement to a third party.
- 16. The Purchaser purchase with full knowledge of the physical condition of the Property and the fittings, finishes and appliances therein and takes them as they stand.

- 23. Time is of the essence of this Preliminary Agreement.
- 24. The Purchaser shall inform the Vendor in writing of any change in address or telephone number.
- 25. If the Property under this Preliminary Agreement consists of a residential property as well as any Residential Parking Space(s) or Motor Cycle Parking Space(s), such Property shall be covered by one single formal agreement for sale and purchase and one single subsequent assignment.
- 26. The Land Grant stipulates that the Residential Parking Spaces and the Motor Cycle Parking Spaces shall not be assigned except (i) together with a residential property of the Development; or to a person who is already an owner of a residential property of the Development; or underlet except to residents of the residential property of the Development. Subject to the conditions precedent in this paragraph being satisfied by the Purchaser and any other terms and conditions as shall be imposed by the Vendor, the Vendor may grant a licence to the Purchaser to occupy the Property as a licensee prior to the completion of sale and purchase of the Property.

(b) 買方必須簽署許可協議(格式及內容由賣方訂明,買方不得要求任何修改),主要條款如下:

The Purchaser shall sign a Licence Agreement (in such form and content as the Vendor may prescribe and the Purchaser shall not be allowed to make any amendment thereto), the principal terms of which are as follows:

A. 許可佔用期由許可協議指明的日期開始(不得早於接納書日期後180天),並於成交日期或在接納書日期後720天內(以較早者為準)終止。

The licence period shall commence from the date as specified in the Licence Agreement (which shall not be earlier than 180 days after the date of Letter of Acceptance) and shall end upon the completion date or within 720 days after the date of Letter of Acceptance (whichever is earlier);

The licence fee payable by the Purchaser to the Vendor for the licence period shall be equivalent to 2% of the purchase price (the licence fee of Flat B on the 7th Floor of Tower 2, Flat B on the 8th Floor of Tower 2 and Flat B on the 9th Floor of Tower 8 payable by the Purchaser to the Vendor shall be equivalent to 5% of the purchase price);

C. 賣方會在物業買賣完成時將許可費用直接用於支付部份樓價餘額,但前提是:

- (a) 買方已根據買賣合約完成物業買賣;
- (b) 許可費用已依照許可協議訂定的日期付清; 及
- (c) 許可協議的條款及條件已獲全面遵守。

為免存疑,如不符合本第C款規定的任何條件,賣方不會將許可費用於支付部份樓價餘額,買方不能向賣方提出任何索償要求退還許可費用或其任何部分或其任何利息。

The licence fee shall be applied by the Vendor towards settlement of part of the balance of purchase price of the Property upon completion of the sale and purchase subject to the fulfillment of the following conditions:-

- (a) the Purchaser having duly completed the purchase of the Property in accordance with the terms and conditions of the sale and purchase agreement;
- (b) the licence fee has been paid in the manner as set out in the licence agreement; and
- (c) the terms and conditions of the licence agreement have been complied with in all respects.

For the avoidance of doubt, in the event that any one of the conditions stipulated under this paragraph C is not fulfilled, the Vendor shall not apply the licence fee towards settlement of part of the balance of the purchase price of the Property and the Purchaser shall have no claim whatsoever against the Vendor for any refund of the licence fee or any part thereof or any interest thereon.

- D. 在許可佔用期內,買方須負責該物業之管理費、地租、差餉及所有其他雜費(統稱「相關開支」)。
  The Purchaser shall be responsible for management fees, Government rent and rates, and all other outgoings and expenses of the Property (collectively "Relevant Expenses") during the licence period.
- E. 在許可佔用期內,買方須支付為該物業提供的任何公用事業服務的所有按金,以及支付該物業之所有公用事業服務收費。 為免疑問,公用事業服務的按金及收費並不構成相關開支的一部分。 The Purchaser shall pay all deposits payable in respect of the supply of any utility to the Property and pay all utility charges for the

The Purchaser shall pay all deposits payable in respect of the supply of any utility to the Property and pay all utility charges for the Property during the licence period. For the avoidance of doubt, the utility deposits and utility charges do not form part of the Relevant Expenses.

- (c) 於簽署許可協議時,買方必須已向賣方繳付不少於15%的樓價。 Upon signing of the Licence Agreement, the Purchaser shall have paid not less than 15% of the purchase price to the Vendor.
- (d) 買方須承擔所有就許可協議的準備和簽署而產生的所有法律費用及開支及所有就許可協議而產生的印花稅(如有)及印花稅 裁定費。

All legal costs and expenses arising from the preparation and execution of the Licence Agreement and all stamp duty (if any) and adjudication fee arising from the Licence Agreement shall be solely borne by the Purchaser.

(e) 提前入住優惠受任何其他由賣方施加的條款及細則約束。

The Early Move-in Benefit is subject to any other terms and conditions as shall be imposed by the Vendor.

2. 認購一個住宅停車位的權利(適用於如買方沒有連同住宅物業購買任何住宅停車位)

Option to purchase one Residential Parking Space (Applicable if the Purchaser does not purchase any residential parking space together with the residential property)

- (a) 買方可享有認購該發展項目內的一個住宅停車位的權利。買方可根據賣方日後公佈的住宅停車位之銷售安排所規定的時限及 方法行使其認購一個住宅停車位的權利。
  - The Purchaser is entitled to have an option to purchase one residential parking space in the Development. The Purchaser can exercise his/her/its option to purchase one residential parking space in accordance with time limit and manner as prescribed by the sales arrangement of the residential parking spaces to be announced by the Vendor.
- (b) 如買方不根據賣方日後公佈的住宅停車位之銷售安排行使其認購一個住宅停車位的權利,其認購一個住宅停車位的權利將會 自動失效,買方不會為此獲得任何補償。

If the Purchaser does not exercise the option to purchase one residential parking space in accordance with time limit and manner prescribed by the sales arrangement of the residential parking spaces to be announced by the Vendor, the option to purchase one residential parking space shall lapse automatically and the Purchaser shall not be entitled to any compensation therefor.

- (c) 住宅停車位的售價及銷售安排詳情將由賣方全權及絕對酌情決定,並容後公佈。
  - The price and sales arrangement details of residential parking spaces will be determined by the Vendor at its sole and absolute discretion and will be announced later.
- 3. 送贈家具優惠 (只適用於第 2 座 7 樓 B 室、第 2 座 8 樓 B 室、 | 第 8 座 9 樓 B 室及 20 號洋房之買方)

Free Furniture Offer (only applicable to the Purchaser of Flat B on the 7th Floor of Tower 2, Flat B on the 8th Floor of Tower 2, Flat B on the 9th Floor of Tower 8 and House 20)

- (1) 購買第 2 座 7 樓 B 室、第 2 座 8 樓 B 室、|第 8 座 9 樓 B 室及 20 號洋房之買方可免費獲贈現時於該單位內展示的裝飾、物件和家具(統稱為「該家具」)。
  - The Purchaser of Flat B on the 7th Floor of Tower 2, Flat B on the 8th Floor of Tower 2, Flat B on the 9th Floor of Tower 8 and House 20 will be provided with the decoration, items and furniture (collectively the "Furniture") currently displayed at that Unit free of charge.
- (2) 賣方或其代表不會就該家具作出任何保證、保養或陳述,更不會就其狀況、狀態、品質及性能,及其是否或會否在可運作狀態作出任何保證、保養或陳述。該家具將於住宅物業成交日或(如買方已使用提前入住優惠) 住宅物業的管有權交予買方的日期(以較早者計)以成交時或交予管有權時(視乎情況而定)之狀況連同住宅物業交予買方。任何情況下,買方不得就該家具提出任何異議或質詢。本優惠受其他條款及細則約束。

No warranty, maintenance or representation whatsoever is given by the Vendor or any person on behalf of the Vendor in any respect regarding the Furniture. In particular, no warranty, maintenance or representation whatsoever is given as to the condition, state, quality or fitness of any of the Furniture or as to whether any of the Furniture is or will be in working condition. The Furniture will be delivered to the Purchaser upon completion of the sale and purchase of the residential property or (if the Purchaser has utilized the Early Move-in Benefit) the date when possession of the residential property is delivered to the Purchaser (whichever is earlier) in such condition as at completion or delivery of possession (as the case may be) together with the residential property. In any event, no objection or requisitions whatsoever shall be raised by the Purchaser in respect of the Furniture.

## 4. 裝修傢俬禮券優惠

Decoration Coupon Offer

- (a) 如買方於要約表格內選擇裝修傢俬禮券優惠,買方將獲提供金額相等於 HK\$1,280,000.00 的裝修傢俬禮券優惠(「該優惠」)。 If the Purchaser chooses Decoration Coupon Offer, a coupon for decoration services (the "Offer") in the sum equivalent to HK\$1,280,000.00 will be offered to the Purchaser.
- (b) 該優惠由指定裝修公司提供。

The Offer is provided by the designated decoration company.

(c) 在完成該物業買賣後及買方於接收該物業時,買方可免費獲贈由指定裝修公司提供金額相等於 HK\$1,280,000.00 的裝修傢俬 禮券一張(「該禮券」)。

Upon taking possession of the Property after completion of the sale and purchase of the Property, the Purchaser will receive a decoration coupon in the sum equivalent to HK\$1,280,000.00 (the "Coupon") from the designated decoration company.

(d) 買方須於完成該物業買賣後的 30 天內兌換該禮券並與指定裝修公司簽訂有關提供適用於該物業的指明裝修(「該裝修」)之合約。

The Purchaser shall redeem the Coupon within 30 days after the completion date of the sale and purchase of the Property and enter into a contract with the designated decoration company regarding the provision of specified decoration applicable to the Property (the "Decoration").

- (e) 有關該裝修的詳情(包括但不限於設計、顏色及物料),請向指定裝修公司查詢。
  - For details (including without limitation the design, colour and materials) of the Decoration, please enquire with the designated decoration company.
- (f) 若買方未能遵守、履行或符合臨時合約或買賣合約內任何條款或條件,賣方有權即時撤銷該優惠,且並不損害賣方於臨時合約、買賣合約或其他適用法律下之其他權利及濟助。

In the event that the Purchaser fails to observe, perform or comply with any of the terms and conditions contained in the Preliminary Agreement or the Agreement, the Vendor shall be entitled to cancel the Offer forthwith without prejudice to the Vendor's other rights and remedies under the Preliminary Agreement, the Agreement or other applicable laws.

(g) 買方須付清該物業之樓價及按買賣合約完成該物業買賣,不管:

The Purchaser shall settle the full amount of the purchase price of the Property and complete the sale and purchase of the Property in accordance with the agreement for sale and purchase irrespective of whether:

- (i) 就該優惠有否引起任何爭議;及 there is any dispute arising from the Offer; and
- (ii) 該裝修公司交付予買方的所有或任何該裝修是否與該優惠之條款一致。 all or any of the Decoration delivered by the designated decoration company to the Purchaser is in accordance with the terms of the Offer.
- (h) 賣方、其所有控股公司或其代表不會就該優惠及該裝修提供保養或作出任何保證或陳述,更不會就該裝修狀況、狀態、品質、性能或任何該裝修是否或會否在可運作狀態作出任何保證及陳述。如買方對該裝修有任何異議或質詢,應直接聯絡該裝修公司。

The Vendor, all their holding company(ies) or any person(s) on their behalf do not provide any maintenance or give any warranty or representation in any respect regarding the Offer and the Decoration. In particular, no warranty or representation whatsoever is given as to condition, state, quality, fitness of the Decoration or as to whether any of the Decoration is or will be in working condition. If the Purchaser has any objection or requisitions whatsoever in respect of the Decoration, the Purchaser shall contact the designated decoration company directly.

- (i) 為免疑問,就購買每個住宅物業,買方只可享有裝修傢俬禮券優惠或裝修傢俬津貼優惠的其中一項。 For the avoidance of doubt, for the purchase of each residential property, the Purchaser is only entitled to either the Decoration Coupon Offer or the Decoration Subsidy Offer.
- (j) 裝修傢俬禮券優惠受其他條款及細則所約束。 The Decoration Coupon Offer is subject to other terms and conditions.
- 5. 裝修傢俬津貼優惠

Decoration Subsidy Offer

(a) 如買方於要約表格內選擇裝修傢俬津貼優惠,買方將獲提供金額相等於 HK\$1,280,000.00 的裝修傢俬津貼優惠。 If the Purchaser chooses Decoration Subsidy Offer, a decoration subsidy in the sum equivalent to HK\$1,280,000.00 will be offered to the Purchaser.

- (b) 賣方會在該物業買賣完成時將裝修傢俬津貼優惠直接用於支付該物業售價的餘額。
  - The Decoration Subsidy Offer will be applied towards settlement of the balance of purchase price directly upon completion of the sale and purchase of the Property.
- (c) 為免疑問,就購買每個住宅物業,買方只可享有裝修傢俬禮券優惠或裝修傢俬津貼優惠的其中一項。 For the avoidance of doubt, for the purchase of each residential property, the Purchaser is only entitled to either the Decoration Coupon Offer or the Decoration Subsidy Offer.
- (d) 裝修傢俬津貼優惠受其他條款及細則所約束。

The Decoration Subsidy Offer is subject to other terms and conditions.
